## **FULL GOVERNING BODY**

## TERMS OF REFERENCE

### **MEMBERSHIP**

- The governing body shall consist of a minimum of 10 governors and a maximum of 14 governors
- 4 6 Co-opted governors
- 4 5 Parent governors
- 1 2 Staff governors
- Headteacher

## **QUORUM**

- One third of total governor numbers, rounded up to a whole number, to a minimum of three
- For a meeting called to remove a governor or Chair of governors the quorum shall be two thirds, rounded up to a whole number

#### **MEETINGS**

• Three meetings a year, or more frequently as may be required. One meeting to take place during the Autumn term, one in the Spring term and one in the Summer term

### CHAIR AND VICE-CHAIR

• The Chair and Vice-Chair will be elected every two according to the Bradgate Education Partnership Local Governing Body Terms of Reference at the first meeting of the academic year.

## **TERMS OF OFFICE**

- The term of office for all governors will be 4 years with the exception of the headteacher where this time limit does not apply
- · Parent and staff governors must be elected into office
- Co-opted governors will be co-opted on to the governing body

#### **CLERK**

• The governing body will be responsible for appointing a clerk

## **ATTENDANCE**

- Governors are expected to attend all governing body and committee meetings
- Apologies for non-attendance must be made in advance and the governing body must decide whether to accept the apologies and record this in the minutes
- A governor shall cease to hold office if absent without permission of the governors from all their meetings held within a period of six months and the governors resolve that that their office be vacated. This does not apply to the head teacher.

# **VOTING**

- A resolution is passed by a majority of those present
- · The chair has a casting vote if there is a tie
- Voting by proxy will not be admissible

### COMMITTEES

There will be committees to cover the following areas:

- Education
- Finance
- · Health & Safety

- Performance Management of the Headteacher
- Human Resources
- Complaints
- Discipline / Capability / Grievance / Exclusions
- Appeals

## **DESIGNATED GOVERNORS**

There will be designated governors to oversee the specific responsibilities of:

- · Special Needs
- · Training and Development
- Safeguarding

### CODE OF CONDUCT

• All governors are required to sign and abide by the governor's code of conduct

### **SKILLS AUDIT**

- All governors are required to complete a skills audit
- · The skills audit will be reviewed annually

### **DECISION PLANNER**

- The governor's decision planner explains the delegation of responsibilities within the governing body
- The decision planner will be reviewed annually

### TERMS OF REFERENCE

 Terms of reference will be reviewed annually at the first meeting in the academic year of the full governing body

## **DECLARATION OF INTERESTS**

 Where there is a conflict between the interests of any governor and the interests of the governing body, that person must declare the interest and withdraw from any meeting

# **TRAINING**

- In line with the recommendation of the Governor Training and Development Programme it is recommended that all governors should complete the following training courses within the first 2 years of office
  - Governor Visits
  - Induction Training for New Governors
  - Safeguarding Children

And that according to the Bradgate Education Partnership Local Governing Body Terms of Reference each governor attends at least two training events each academic year.
